Mrs. Guenette discussed and reviewed the revised District Wellness Policy NEPN Code ADF.

Mrs. Guenette stated that she will provide evidence to the DESE that it is not safe for students to walk or ride bicycles to school because there are no sidewalks. She stated that the students will have access to walk on the paths and trails of the school campus.
