4. Participates in the limited assembly of foods, such as assembling sandwiches and salads.
5. Assists in the preparation of foods and with joint tasks when other assigned tasks are completed.
6. Dresses appropriate to the tasks and the work place and to essentially meet the standards of safety, health and cleanliness.
7. Performs such other tasks and assumes such other responsibilities as may be designated or assigned by the Cafeteria Manager from time to time.
