You should have received an email last week that had your students' name, school ID# and balance on meal account. You can use this information to look up you student in My School Bucks, to create an account and deposit money so they are all set for day one. Please look below for the information on My School Bucks from last week's letter. If you have not received an email please check your spam folder, still nothing, contact me so I can make sure I have the correct information on file. Unfortunately, at this time I can only send information to one contact per student.

Special Diets: Go to [Old Colony's website](#), select STUDENTS or PARENTS in the navigation bar (across the top of the page), select Cafeteria Information, scroll down and select Special Diet Information and On-line Order. Once you are here, you can select the special diet you are looking for and this will lead you to the Lunch order form. I will have the following weeks order form posted by Friday of each week. Please fill it out and submit it by Sunday night so we have it first thing Monday Morning. We start early☺ I am hoping to have the first order form posted by Thursday August 26th, I am still waiting on the details of my serving line installation and wanted to hold off to minimize confusion on menu change.

Meals will remain free for the entire school year. Every student can get one free breakfast and one free lunch each day. There will be fees/charges if they want a second meal, double or other ala-carte items. If there is any question with [what is included](#) with, a meal please ask one of the cafeteria staff. Look for these logos on our webpage to view our menus. Menus have been posted for August & September 2021. Our cafeteria is getting a much-needed new service line this year. Unfortunately, with all the delays in

delivery we may not have it in for day one, so the menu on a couple of days may be changed to accommodate what we will have available for service. Fingers crossed it will only effect a couple of days. I will keep you updated, as I know. No matter what, we will still have meals available for breakfast & lunch every day.



We will continue to be a cashless environment during all meal services and all students will need their School ID's on them at all times.

[My School Bucks](#) is the online system that allows you to view what your child has purchased and make a deposit to the school meals account. You can deposit money into their account before school starts! Just select the MySchoolBucks Icon on our [web page](#) to set up an account. Any new students will be updated in the system by 08/13/2021. You will have an opportunity to make recurring deposits or individual deposits, as you need them.

If you prefer to send in a check, please make the check payable to Old Colony. On the memo line, put your child's name & ID number. **The check must be in a sealed envelope with your child's name and ATTN: Cafeteria on the front.** Your child will need to bring this to the front office first thing in the morning or in the drop box located by the registers at breakfast. We will then deposit money onto accounts before lunch service begins. Please do not forget to write all information on envelope. 😊

To purchase meals is the same for everyone, whether they have money on their account or have free or reduced priced meals. All your child will **need** is their **Student ID at the register for both Breakfast & Lunch.** On their ID is a barcode that they will scan at the register. If this is their first year at Old Colony and they do not have an ID yet, we will provide them with a copy of their barcode on or before the first day of school.

Yes, meals are free for everyone but there may be other opportunities/benefits if you qualify for free or reduced price meals. Please fill out an application if you would like to see if you qualify.

**Free & Reduced Meal Applications will be available on-line as of Friday 8/13/2021. Please check our website for the link [here](#). You will have the option to fill it out on-line or print a paper copy and send it in to me at school. All free and reduced applications sent back to school by August 25th will be processed before the first day of school. PLEASE make sure you are using the applications posted online: 2021-2022 Application. I will not be able to use prior year's applications. In addition, if you have a student who is attending another school district I will need a separate application. We are the only school in this district and we do not share application information with other schools.
