Hours needed 9:30 a.m. - 1:30 p.m.

Cafeteria worker needed to prepare and serve the students' in a pleasant, efficient manner as they relate to the School Lunch Program. The cafeteria worker will report to the School Nutrition Director.

Qualifications:

- Ability and willingness to follow instructions.
- Ability to lift 40lbs or more
- Ability to stand for long periods of time during shifts
- Ability to work in a fast paced environment
- Basic math and reading skills
- Basic knowledge of food sanitation procedures and practices.
- Cleanliness
- Demonstrates ability to work both as a team member and independently as required by the assignment

Requirements:

1. Assumes responsibility for food service operations as they may apply and/or are assigned.
2. Serve food provided in an appealing manner.
3. Assures the cleaning of all serving areas and other items related to the production, serving or storing of all foods used.
4. Participates in assembly of foods, such as sandwiches, salads & daily specials.
5. Assists in the preparation of foods and with the joint tasks when other assigned tasks are completed.
6. Dresses appropriate to the tasks and the workplace and essentially meet the standards of safety, health & cleanliness.
7. Performs such other tasks and assumes such responsibilities as may be designated or assigned by the School Nutrition Director from time to time.
8. Required to complete 6 hours of professional development annually.
9. ServSafe certification will be required if applicant is selected for the position. The certification must be maintained with recertification every five years.

The above statements are intended to describe the general nature and level of work being performed by employees assigned to this classification. They are not intended to be construed as an exhaustive list of all responsibilities and duties required of those in this classification. A job description is available upon request.
