We have a couple of updates and some new things happening in the cafeteria.

I cannot believe we only have one month left. What a fast year!!

First, for a little housekeeping... Please keep all accounts up to date. Balances should be paid in full. Any money left on account will roll over to next school year. We try to get all students through the line as fast as possible, in doing this we will keep it a cashless environment at both breakfast and lunch. Students must have money on their account to purchase additional items. Please see below for information on how to deposit funds into an account.

We will still be offering a free water with all meals. We will be changing the bottle to an 8oz bottle instead of a 16oz bottle. This is an added offer we want to offer, not a requirement. There is a water fill up station that can be used to refill the bottle.

Additional 8oz bottles of water can be purchased for \$0.50. 16oz bottles will be available in the vending machines for \$1.00.

We have added a couple of vending machines in our cafeteria. There have been a few bumps in the road getting it started but all seems to be heading in the right direction. Eventually we will have some meals, sandwiches, smoothies and other grab & go items that offer more than just the quick snack or bag of chips. All can use cash but students and staff can also use their school meal accounts to make purchases. There is a 2-step verification process to make sure the information is entered correctly. The vending machines will be a great option to add an additional service line during school hours and will be available for anyone after school hours.

Dear Parents and Caregivers,

We want to update you with exciting news about universal free school meals. The Commonwealth of Massachusetts has decided to extend free school meals for all students through the 2022-2023 school year! This means that all students can receive one free breakfast and one free lunch every day.

Please note that even though meals will be free for all, it is very important for families to still complete the household Application for Free and Reduced Price Meals for the 2022-2023 school year. We strongly encourage ALL families to submit this form as it allows us to establish eligibility for P-EBT benefits, for other benefit and fees throughout the school year, and to serve families most effectively.

Free & Reduced Meal Applications will be available on-line as of Wednesday 8/10/2022. Please check our website for the link [here](#). You will have the option to fill it out on-line or print a paper copy and send it in to me at school. All free and reduced applications sent back to school by August 26th will be processed before the first day of school. **PLEASE make sure you are using the applications posted online: 2022-2023 Application.** I will not be able to use prior year's applications. In addition, if you have a student who is attending another school district I will need a separate application. We are the only school in this district and we do not share application information with other schools.

Second Meal & Ala Carte Charges: Yes, meals will remain free for the entire school year. Every student can get one free breakfast and one free lunch each day. There will be fees/charges if they want a second meal, double or other ala-carte items. If there is any question with [what is included](#) with a meal please ask one of the cafeteria staff. We will continue to be a cashless environment during all meal services and all students will need their School ID's on them at all times.

To purchase meals is the same for everyone, whether they have money on their account or have free or reduced priced meals. All your child will need is their **Student ID at the register for both Breakfast & Lunch.**

On their ID is a barcode that they will scan at the register. If this is their first year at Old Colony and they do not have an ID yet, we will provide them with a copy of their barcode on or before the first day of school. All past year, Old Colony ID's will have the same bar code. Students will not need to wait to have a new ID for this school year.

Deposit Funds on Student Account: [My School Bucks](#) is the online system that allows you to view what your child has purchased and make a deposit to the school meals account. You can deposit money into their account before school starts! Just select the MySchoolBucks Icon on our [web page](#) to set up an account. Any new students will be updated in the system by 08/10/2022. You will have an opportunity to make reoccurring deposits or individual deposits, as you need them.

You should have received an email this past week that had your students' name, school ID# and balance on meal account. You can use this information to look up you student in My School Bucks, to create an account and deposit money so they are all set for day one. **If you have not received an email please check your spam folder, still nothing, email me so I can make sure I have the correct information on file.**

If you prefer to send in a check, please make the check payable to Old Colony. On the memo line, put your child's name & ID number. **The check must be in a sealed envelope with your child's name and ATTN: Cafeteria on the front.** Your child will need to bring this to the front office first thing in the morning or in the drop box located by the registers at breakfast. We will then deposit money onto accounts before lunch service begins. Please do not forget to write all information on envelope. 😊

Special Diets: Go to [Old Colony's website](#), select STUDENTS or PARENTS in the navigation bar (across the top of the page), select Cafeteria Information, scroll down and select Special Diet Information and On-line Order. Once you are here, you can select the special diet you are looking for and this will lead you to the Lunch order form. I will have the following weeks order form posted by Friday of each week. Please fill it out and submit it by Sunday night so we have it first thing Monday Morning. We start early 😊 I am hoping to have the first order form posted by Thursday August 25th.
